COVID-19 Response

AB-327 (Kiley) - COVID-19 vaccination status: prohibition on required disclosure.

This bill would prohibit state agencies, local governments, and any other state governmental authority from adopting or enforcing any order, ordinance, policy, regulation, rule, or similar measure that requires an individual to provide, as a condition of receiving any service or entering any place, documentation regarding the individual's vaccination status for any COVID-19 vaccine administered under an emergency use authorization as well as prohibit any public or private entity that receives or is awarded state funds from requiring a member of the public to provide, as a condition of receipt of any service or entrance to any place, documentation regarding the person's vaccination status for any COVID-19 vaccine administered under an emergency use authorization.

Earthquake Mitigation and Response

AB-1721 (Rodriguez) - California Emergency Services Act: emergency preparedness: mutual aid: seismic retrofitting soft story multifamily housing.

While held, the text of this bill became part of the budget package and establishes a \$400 million seismic retrofit program for multifamily soft story buildings to be administered by the California Office of Emergency Services (Cal OES) and the California Earthquake Authority (CEA).

Emergency Communications

AB-1100 (Aguiar-Curry) - Communications service: emergencies and disasters: reports.

This bill would have required the California Public Utilities Commission (CPUC) to collect specified information related to the damage, repair, restoration, and backup generation of telecommunications infrastructure as a result of a fire or other disaster.

AB-1314 (Ramos) - Emergency notification: Feather Alert: endangered indigenous people.

This bill established the Feather Alert system, to aid in the location of an Indigenous person who has gone missing under suspicious circumstances, been abducted or kidnapped.

This bill would have required the California Public Utilities Commission (CPUC) to, within 12 months of a declaration of emergency from the Governor, collect information, as specified, from broadband service providers on infrastructure damaged by the disaster and share this information with the legislature annually.

Emergency Declarations

AB-69 (Kiley) - State of emergency: termination after 60 days: extension by the Legislature.

This bill would require a state of emergency to terminate 60 days after the Governor's proclamation of the state of emergency unless the Legislature extends it by a concurrent resolution and would prohibit a concurrent resolution from extending a state of emergency by more than 60 days.

Governor's Veto Message:

Governor's veto message: To the Members of the California State Assembly:

I am returning Assembly Bill 1403 without my signature.

This bill would specify that conditions constituting a state of emergency under the California Emergency Services Act may include a DE energization event, defined as a planned power outage.

This legislation is unnecessary, as existing statute provides broad emergency authority when disaster conditions are met.

AB-1687 (Seyarto) - California Emergency Services Act: Governor's powers: suspension of statutes and regulations.

This bill would have clarified that the Governor may only suspend a statute or regulation during a state of emergency in connection with the specific conditions of the emergency.

Governor's Veto Message:

Governor's veto message: To the Members of the California State Assembly:

I am returning Assembly Bill 1687 without my signature.

This bill provides that the Governor, during a state of emergency or state of war emergency, may only suspend a statute or regulation that is in connection with the specific conditions of the proclaimed emergency.

At best, this bill is redundant and therefore unnecessary. The Emergency Services Act already requires any suspension of laws or regulations issued by the Governor during times of emergency or war be directly related to the mitigation of the declared emergency. By imposing duplicative obligations, this bill compromises the state's ability to swiftly respond to the needs of residents in times of crisis.

Additional redundant layers of justification, as required by this bill, would only invite frivolous lawsuits. This could delay or derail state emergency response and recovery efforts, negatively impacting the most vulnerable California residents and potentially costing lives.

For these reasons, I cannot sign this bill.

AB-2212 (Gallagher) - California Emergency Services Act: state of emergency: Governor's powers.

This bill would only authorize the Governor to exercise within the area designated all executive power vested in the state by the Constitution and laws of the state to effectuate the purposes of the CESA instead of existing law which authorizes the Governor complete authority over all agencies of the state government and the right to exercise within the area designated all police power vested in the state by the Constitution and laws of the state to effectuate the purposes of the CESA.

Governor's Veto Message:

Governor's veto message: To the Members of the California State Assembly:

I am returning Assembly Bill 418 without my signature.

This bill codifies a previously funded grant program within the Office of Emergency Services to improve resiliency during power outage events.

I recognize the importance of providing resources to help mitigate the impacts of public safety power shutoffs (PSPS). Since 2019, California has invested \$125 million to counties, cities, special districts, and federally-recognized tribes for this purpose. The state also adopted more stringent requirements for utilities to mitigate the impacts of PSPS events and created the Office of Energy Infrastructure Safety to oversee utility resiliency and wildfire prevention efforts.

To the extent a future appropriation is provided for community power resiliency efforts, this bill would eliminate administrative flexibility to direct funding where it is needed most. For example, the state was able to allocate funding from the 2020 Budget Act to ensure power for critical public health facilities like COVID-19 testing sites during the pandemic.

Furthermore, as this bill seeks to codify a grant program, it results in ongoing General Fund cost pressures. Changes to the nature and duration of a grant program are more appropriately considered through the annual state budget process.

AB-433 (Chen) - California Wildfire Mitigation Financial Assistance Program: electrical utilities: voluntary contributions.

This bill would authorize the joint powers developing and administering a comprehensive wildfire mitigation program, the Office of Emergency Services and the Department of Forestry and Fire Protection, to accept voluntary contributions and would require the contributions be deposited in the California Wildfire Mitigation Financial Assistance Fund, which the bill would establish in the State Treasury.
